In accordance with the Constitution (10.2) there are the following vacancies on the Board for 2010:

Proposals for future Board members must be submitted to the SABBA Office on or before **15 December, 2009** together with a short resumé of the candidate.

Such a resume should provide a summary of the proposed candidate's historical involvement with the Boerboel and SABBA and/or equivalent breed and/or organisation, as well as contribution (e.g. as owner, breeder, appraiser, regional coordinator, relevant courses attended, former Board Member, etc.)

In addition, the motivation for election and the candidate's objectives as a Board Member should be clearly defined.

The candidate, as well as his/her proposer and seconder, or an authorised person (if a valid apology is received) must be present at the election.
